From the Heart by Fr. Jason Kern

Dear Parishioners,

I write to you today to inform you that two of our parishes, St. Teresa and St. Joseph have been named in a lawsuit alleging sexual abuse of a minor. Currently there are four civil lawsuits of child sexual abuse against the Diocese of Winona and St. Teresa Church dating between 1976 and 1984 by Father William Curtis. Father Curtis died April 10th, 2001. There is one civil lawsuit of child sexual abuse against the Diocese of Winona, Loyola Catholic Schools, and St. Joseph Church dated between 1969-1970 by Father Joseph Cashman. Father Joseph Cashman was permanently removed from ministry in 1992 and laicized in 2014.

These are not new cases as they date back several decades. The claims being brought forward do not involve anyone currently at our parish or anyone active in ministry in the Diocese of Winona. Both St. Teresa and St. Joseph have retained legal counsel from Meier, Kennedy, & Quinn out of St. Paul with Attorney Tom Weiser representing us. This firm has been recommended to represent the majority of parishes being sued in the Diocese of Winona. The Diocese of Winona has separate legal counsel. Our attorneys are in the process of conducting a search for insurance and will plan to use any available insurance coverage while ensuring that the mission of the parish continues. We still do not know all the details of this suit, but as more information is available we will communicate this with the parish community.

I have made available after the weekend Masses a letter from Bishop Quinn and a fact sheet about the current work the Diocese of Winona is doing to protect children and assure these heinous acts never occur again.

I ask our parish community to pray for healing for anyone who has suffered sexual abuse.

Additionally, I encourage anyone who has been a victim of child sexual abuse to report the abuse to civil authorities. Survivors should file by May 25th (the final date of the statute of limitations being lifted by the Child Victims Act) as our communities work toward healing and a just resolution to these cases.

As your pastor, I will not allow child sexual abuse to define our communities. Jesus Christ is Lord and God and wants His Church to be purified of all evil most especially the harm done to minors. I continue to pray in reparation for all sin and ask for mercy to be upon our Church in these days.


